Therefore, it is not possible to merge QKB CI 30 into any QKB that was released prior to QKB CI 2010B. If a merge is desired, first install QKB CI 30 in a new location and then merge the QKB CI version prior to 2010B into QKB CI 30. This definition is no longer supported and will be removed in a future release. Switch any jobs that use the definition to use the replacement definition specified.

Modify jobs or the QKB to use the desired definition

Each definition that has been enhanced will also have a copy of the original version. The original definition is tagged and deprecated to be replaced by an enhanced definition that requires job changes. The required job changes for the enhanced definition are described in the Deprecation Action section. Users can do one of the following three options:

- 1. Modify their jobs to fit the new definition.
- 2. Modify their jobs to use the old QKB.
- 3. Modify the QKB by removing or renaming the new definition and then untag the old definition.

Users are encouraged to modify their jobs to take advantage of the enhanced processing.

Modify jobs to use the updated definition

- Identity names have changed
 The identity names of the definition have changed. This change requires an update to jobs that use the definition so that the identity names that are specified in those jobs match the names in the definition.
- 2. Pre-parsed input changes Certain data quality functions expect input data that has been previously parsed. In SAS Data Quality Server, these functions are

DQGENDERPARSED and DQMATCHPARSED. In DataFlux Data Management Studio the nodes are Gender Analysis (Parsed), Standardization (Parsed), and Match Codes (Parsed).

- Definition no longer accepts pre-parsed input
 If this definition is called by any of the pre-parsed input data quality
 functions or nodes, change it to use the corresponding function or node
 that does not expect pre-parsed input and provide the input as a single
 field. Jobs using functions or nodes without PARSED or (Parsed) will not
 require an update.
- Pre-parsed input tokens have changed
 If this definition is called by any of the pre-parsed input data quality
 functions or nodes, change the mapping of the input fields to the tokens
 used by the enhanced definition. Jobs using functions or nodes without
 PARSED or (Parsed) will not require an update.
- 3. Output tokens have changed Update jobs using the definition so that the output tokens of the enhanced definition are expected by those jobs.
- 4. Match code length has increased Check any jobs using the definition to ensure that the match code fields can accommodate a match code with the new length.



Known Problems

- Due to the complexity of full addresses, jobs using **Address (Full)** match, parse, and standardization definitions might take a long time to complete.
- Due to the complexity of Indian addresses, jobs using the Address, Address (Global), and Address (Full) match, parse, and standardization definitions in the English, India locale might show higher rates of error than are typical for other definitions. Jobs using these definitions might also take a long time to complete.
- Due to the large number of possible telephone area codes in Germany, extensive processing is required to parse German telephone numbers.
 Therefore, jobs run using the **Phone** match, parse, and standardization definitions in the German, Germany locale might take a long time to complete.
- When multiple locales are selected, the QKB installer for Windows might overestimate the amount of disk space required to complete the installation.
