

SAS[®] Money Laundering Detection 1.4

This Road Map briefly describes the media contained in your SAS Money Laundering Detection 1.4 package and how to proceed to install the software.

Description of Your Package

Your package contains installation kits, each representing a distinct functional area of your solution. You should set these installation kits aside until the implementation team reads the *Solution Planning Guide*, which you can download from the SAS Anti-Money Laundering Resource Center at <http://support.sas.com/aml/>. Please contact SAS Technical Support at <http://support.sas.com/techsup/contact/index.html> for the user name and password required to access the Resource Center. For U.S. and Canadian customers, support is provided from our corporate headquarters in Cary, North Carolina. You may call **(919) 677-8008**, Monday through Friday. Customers outside of the U.S. can obtain local-language technical support through the local office in their countries. The two installation kits in your package are labeled as follows:

- **SAS Money Laundering Detection Server**
- **SAS Money Laundering Detection Client**

SAS Money Laundering Detection is a solution made up of the SAS Foundation, including several SAS products, SAS Money Laundering Detection Server (optionally including SAS Money Laundering Detection Watch List Management), and SAS Money Laundering Detection Client software.

How to Proceed

Step 1: Prepare for the installation.

- Download and read the *Solution Planning Guide*. This document explains concepts, considerations, and preparation steps that are required before handling this software.

Step 2: Install the SAS Money Laundering Detection Server.

- Read and complete all of the steps in the *QuickStart Guide* in order to install SAS Money Laundering Detection Server.

- ❑ Follow the instructions in the *Installation Manual* to install the SAS Money Laundering Detection Server.
- ❑ If your installation includes SAS Money Laundering Detection Watch List Management, follow the instructions in the *Installation Manual* to install it.

Step 3: Install the SAS Money Laundering Detection Client.

- ❑ Read and complete all of the steps in the *QuickStart Guide* in order to install SAS Money Laundering Detection Client.
- ❑ Follow the instructions in the *Installation Manual* to install the SAS Money Laundering Detection Client.

This installation kit also includes copies of the **System Requirements Wizard for SAS Enterprise Guide** CD and the **SAS Enterprise Guide** CD. This is optional software that you may use to enhance reporting. It may be installed on any Windows machine.
